Prepare to work safely in the

construction industry (White Card)

Overview

This unit of competency specifies the mandatory work health and safety training required prior to undertaking construction work.

The unit requires the person to demonstrate personal awareness and knowledge of health and safety legislative requirements in order to work safely and prevent injury or harm to self and others. It covers identifying and orally reporting common construction hazards, understanding basic risk control measures, and identifying procedures for responding to potential incidents and emergencies. It also covers correctly selecting and fitting common personal protective equipment (PPE) used for construction work.

This unit meets the general construction induction training (white card) requirements of Part 5.1 of the Occupational Health and Safety Regulations 2017 for Victoria.



Upon successful completion of this unit of competency, you will receive a nationally recognised statement of attainment **CPCWHS1001 Prepare to work safely in the construction industry** issued by Select Security Training Academy.

You will also receive a construction induction training (White Card) issued by WorkSafe Victoria, allowing you to perform construction work at a workplace. SSTA will apply to WorkSafe on your behalf and you should expect the card in the mail approximately two weeks after successfully completing the course.

Licensing & Regulatory Requirements

Licensing, legislative, regulatory or certification requirements apply to this unit of competency.

As set out in part 5.1 of the Victorian Occupational Health & Safety Regulations 2017, a person must not do construction work at a workplace unless they are registered to perform that work. An application to WorkSafe for the registration of a person to perform construction work in a workplace must include proof of identity and a statement of attainment for *CPCWHS1001 - Prepare to work safely in the construction industry*, issued by an approved RTO.

In Victoria, all construction induction training courses must be conducted in a face-to-face classroom environment. Construction Induction Training is not permitted to be delivered online.

People who need a white card include:

- site managers, supervisors, surveyors, labourers and tradespeople;
- people who access construction zones;
- workers whose employment causes them to routinely enter operational construction zones.
